I am requesting \$423,670 for the Sunnyside Foundation to implement and execute art and mobility reactivation activities at the El Pueblo Neighborhood Center for fiscal year 2023.

The entity to receive funding for this project is Sunnyside Foundation located at 2238 E Ginter Rd., Rm 3A in Tucson, AZ 85706. The location of the project is 101 W. Irvington Rd.

The Sunnyside Foundation is requesting funding to begin the historical registry and restoration process for existing murals at El Pueblo Neighborhood Center, to create two new community murals at El Pueblo Neighborhood Center, to establish a community bike lending library for southside neighborhoods and to establish mobility services that include bike repair and safety clinics.
