I am requesting \$2,900,000 under the FY 24 HUD-Economic Development Initiative program for the City of Douglas' Downtown Revitalization Project.

The Douglas Downtown Revitalization Project will be transformational for economic development for Douglas, will span three blocks and expand pedestrian sidewalks, construct road diets to slow traffic, pave the street, and add decorative elements to beautify downtown. The project aims to improve access for the community, increase safety for pedestrians and cyclists, encourage healthier lifestyles, revitalize the downtown area, and support businesses and job growth. The funds will be used to fund the rehabilitation of historic G Avenue.
